ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
AGC-SP3, INC.
(a Florida corporation)

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following articles of amendment to its Articles of Incorporation:

1. The name of the corporation is AGC-SP3, INC., a Florida corporation.
2. The following amendment of the Articles of Incorporation was adopted by the sole shareholder and directors of the corporation on July 23, 1997, in the manner prescribed by the Florida Business Corporation Act:

Article 1 is hereby amended to change the name of the corporation from AGC-SP3, INC., Florida corporation, to WEST FRISCO DEVELOPMENT CORPORATION, a Florida corporation.

3. The remainder of the provisions of the Articles of Incorporation shall remain as filed on June 8, 1997, effective June 8, 1997.
