**ARTICLE ONE**

**The name of the corporation is: DONNA KAUFMAN COMPANY**

**ARTICLE TWO**

**The period of its duration is perpetual.**

**ARTICLE THREE**

**The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.**




