ARTICLES OF INCORPORATION
OF
BARRETT TRANSPORT CORP.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be BARRETT TRANSPORT CORP.

ARTICLE II - PRINCIPAL OFFICE

The principal office address for the corporation is 1527 Skyline Drive, Kissimmee, Florida 34744.

ARTICLE III - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

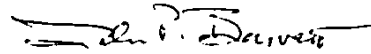
ARTICLE IX - AMENDMENT TO ARTICLES

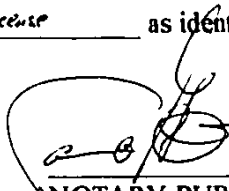

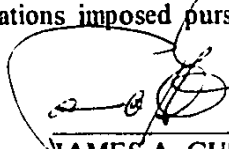
