The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. NAME

The name of this corporation shall be Murphy's Carpet & Upholstry Cleaning, Inc.

Article II. PLACE OF BUSINESS

The principal place of business of this corporation shall be 5549 - 97th Terrace Pinellas Park, FL 33782.

Article II. NATURE OF BUSINESS

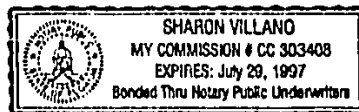
