

# ARTICLES OF INCORPORATION

of
Duria Ventures, Inc.

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

## ARTICLE I - CORPORATE NAME

The name of this corporation is Duria Ventures, Inc.

## ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

## ARTICLE III - PURPOSE

The corporation is organized for the purpose in engaging in activities or business permitted under the laws of the United States and the State of Florida, more particularly described as follows:

- a. To own and operate a retail Asian and Caribbean food mart/grocery store;
- b. To service the public with soda and snack vending machines at various area outlets;
- c. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them;
- d. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.
