THE UNDERSIGNED subscriber to these Articles of Incorporation hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this corporation is BUSINESS WEB DESIGN, INC., and the mailing address and principal place of business shall be 2077 West 76th Street, Hialeah, FL 33016.

ARTICLE II

This Corporation shall have a perpetual existence.

ARTICLE III

The Corporation is organized to engage in any business or purpose lawful under the Laws of the State of Florida.






