OF

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "**Corporation**") under the Florida Business Corporation Act (the "**Act**"), as follows:

**I.
Name**

The name of this corporation is **SDI SERVICES, INC.**

**II.
Term of Existence**

The Corporation's existence commences on the date of the filing of these Articles of Incorporation with the Department of State of the State of Florida. The Corporation will have perpetual existence thereafter.

**III.
Principal Office**

The principal office and mailing address of the corporation is 3650 Spectrum Blvd., Suite 130, Tampa, Florida 33612.

**IV.
Capital Stock**

The Corporation is authorized to issue 100,000 shares of \$0.01 par value common stock, which will be designated Common Stock. The Common Stock will consist of 2 classes: 50,000 shares of Class A voting stock and 50,000 shares of Class B nonvoting stock.

Therefore, the terms and provisions of Section 607.0902 will not apply with respect to any control-share acquisition of any equity securities of the Corporation and the equity securities of the Corporation will have any and all other rights and privileges available under the Act.
