## ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporations Act, adopts the following Articles of Incorporation for such corporation TALLAHASSEE. FLORIDA

- The name of the corporation is Eagle's Sales and Name. Marketing, Inc.
- 2. Principal Office/Mailing Address. The principal office of the corporation is 1214 Trafalgar Drive, New Port Richey, FL, 34655. The mailing address is the same.
- Commencement of Existence. The existence of the corporation will commence on the date of filing of these Articles of Incorporation.
