ARTICLE I - NAME

The name of this corporation is G. D. CRAWFORD & ASSOCIATES, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the Laws of the United States and Florida, including but not limited to ownership of real estate and operation of a construction company and all services and activities related thereto.

ARTICLE IV - CAPITAL STOCK


