ARTICLES OF INCORPORATION

KINDER INTERNATIONAL, INC.

TALLAHASSEE, FLORIDA

ARTICLE I. The undersigned, Carolyn Kinder, whose address is 4521 107th Circle N, Unit 4, Clearwater, Florida 34622, being a natural person over the age of eighteen (18) years, does hereby act as the incorporator to form a corporation under Chapter 607, Florida Statutes.

ARTICLE II. The name of the corporation (which is hereinafter called "Corporation") is Kinder International, Inc.

ARTICLE III. The purpose for which the Corporation is formed is to conduct any lawful business within or without the State of Florida.

ARTICLE IV.
