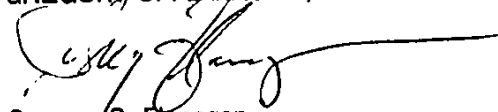

**ARTICLES OF INCORPORATION

The undersigned, for the purposes of forming a corporation under Chapter 621, Florida Statutes, the Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the corporation shall be **DAVID E. HILL, P.A.**

**ARTICLE II**

**COMMENCEMENT AND DURATION**

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence shall be effective with the filing of these Articles of Incorporation.

**ARTICLE III**

**PURPOSE**

The general nature of the business to be transacted by this Corporation is to operate and maintain an establishment and otherwise serve the convenience of its shareholders in carrying on and engaging in the practice of law, and, in general to engage in any and all lawful business permitted under the laws of the United States and the State of Florida, as well as to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV**

**CAPITAL STOCK**

The aggregate number of shares of capital stock which the corporation is authorized to issue is One Thousand (1,000) shares. Such shares shall be of a single class, common stock, and shall have a par value of One Dollar (\$1.00) per share.

**ARTICLE V**

**PRINCIPAL OFFICE/MAILING ADDRESS**

The street address of the initial principal office of the corporation is: 2320 Northeast Second Street, Suite 1-A, Ocala, Florida 34470. The mailing address of the corporation shall be the same.

**ARTICLE VI**

**REGISTERED AGENT/REGISTERED OFFICE**

**ARTICLE VII**

**INITIAL BOARD OF DIRECTORS**

The shareholders may adopt, by written agreement, a plan providing for pre-emptive rights as to the issuance, sale or transfer of any stock. If such agreement exists there shall be printed on the face of all stock in a legible manner, proper words to notify any holder, buyer or transferee thereof of such agreement.

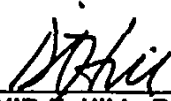
