I. Name



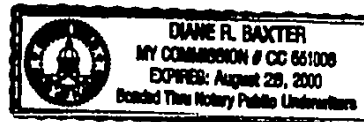
