

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The name of the Corporation shall be DEEP SEA DELIGHTS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office and the mailing address of the Corporation shall be
7214 N. Rome Avenue, Tampa, Florida 33604.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of operating a seafood and
chicken restaurant and conducting any other lawful business.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue 7,500 shares of \$1.00 par value
common stock, which should be designated "Common Shares."

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this
Corporation of the same kind, class or series as that which he already holds,


