ARTICLE ONE





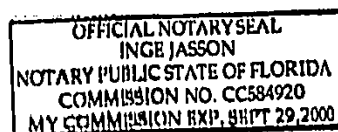
