The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

FLORIDA COASTAL MORTGAGE, INC.

The address of the principal office of this corporation shall be 825 Northeast 199th Street, Unit 108, Miami, Florida 33179, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

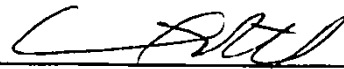
