The undersigned Incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

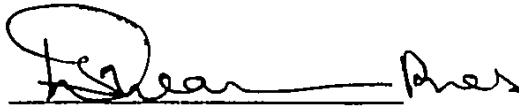
#### **ARTICLE VIII. PRIVATE PROPERTY**

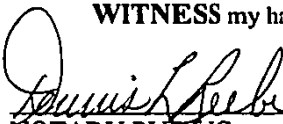

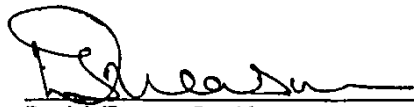
