The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I: NAME

The name and address of the initial Board of Directors of the corporation is Wilene D. Dozier, 2421 Grand St. Jacksonville, Florida 32209.

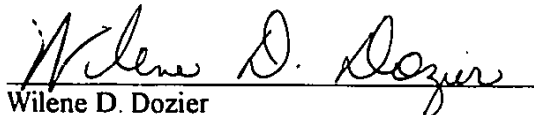
#### ARTICLE VIII: INDEMNIFICATION
