**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the corporation is Blue Sky Investments of South Florida, Inc.

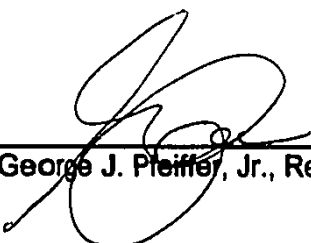
