The aggregate number of shares, which the corporation shall have authority to issue, is two hundred (200) of no par value.

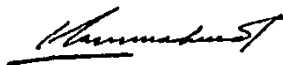
**ARTICLE FIVE**

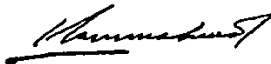
**ARTICLE EIGHT**
