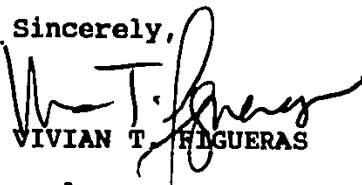

**ARTICLES OF INCORPORATION**  
**OF**  
**MOBULI PRODUCTIONS, INC.**  
A Florida Corporation

The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**NAME**

The name of the corporation is **MOBULI PRODUCTIONS, INC.**

**ARTICLE II**

**DURATION**

The corporation shall have perpetual existence.

**ARTICLE III**

**PURPOSE**

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

**ARTICLE IV**

**CAPITAL STOCK**

The corporation is authorized to issue 1,000 shares of One Dollars (\$1.00)

par value common stock.

#### ARTICLE V

##### INITIAL REGISTERED OFFICE AND AGENT AND PRINCIPAL OFFICE

The street address of the initial registered office of the corporation is 2801 PONCE DE LEON BOULEVARD, SUITE 1170, CORAL GABLES, FLORIDA 33134, and the name of the initial registered agent of the corporation at that address is VIVIAN T.
