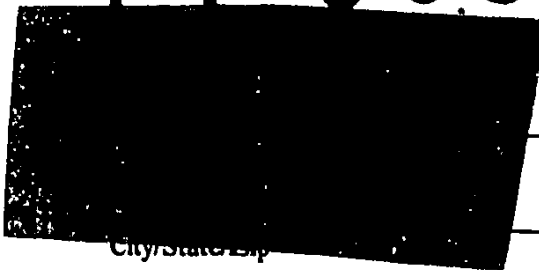

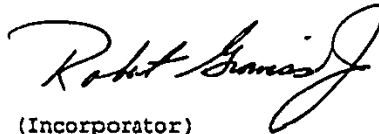
EIGHTH
INDEMNITY
