THE UNDERSIGNED HEREBY MAKES, SUBSCRIBES, ACKNOWLEDGES AND FILES THE FOLLOWING ARTICLES OF INCORPORATION:

#### ARTICLE 1

THE NAME OF THIS CORPORATION SHALL BE:

#### ARTICLE II

THE STREET ADDRESS IN THIS STATE OF THE PRINCIPAL OFFICE OF THIS CORPORATION SHALL BE: 2213 E ATLANTIC BLVD POMPANO BEACH, FL 33062

THE CORPORATION SHALL HAVE PERPETUAL EXISTENCE, COMMENCING WITH THE FILING OF THESE ARTICLES.
