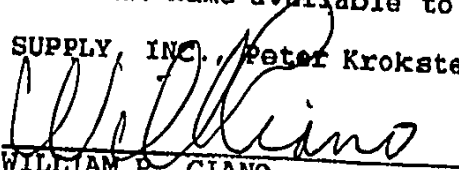
## AFFIDAVIT

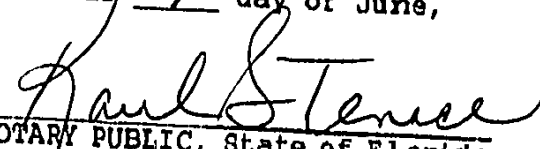

ARTICLE I

NAME

The name of this corporation is: FLORIDA NET & SLING SUPPLY, INC. and the street address of the initial principal office is 8183 N. W. 74 Avenue, Medley, Florida 33166.

ARTICLE II

TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III

PERMITTED ACTIVITY

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may hereafter be amended.

ARTICLE IV

AUTHORIZED SHARES

This corporation is authorized to issue 1000 shares of One Dollars (\$1.00) par value common stock which shall be designated as "Common Shares."

## ARTICLE V

### PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

## ARTICLE VI

### REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation and initial place of business is 8183 N. W. 74 Avenue, Medley, Florida 33166. The initial Registered Agent is Bjorn M. S. Anderson.
