**ARTICLES OF INCORPORATION
OF
COLLEGE PARK IMPORTS CORPORATION**

The undersigned incorporator, a natural person competent to contract, hereby forms a corporation for profit under the Florida Business Corporation Act and other laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - DURATION

This corporation will exist perpetually.

ARTICLE III - PURPOSE
