ARTICLES OF INCORPORATION

OF

PROFESSIONAL WINDOW TREATMENTS, INCLLAHASSEE, FLORIDA

ARTICLE I

The name of this corporation shall be: PROFESSIONAL WINDOW TREATMENTS, INC.

ARTICLE II

This corporation shall have perpetual existence, unless-sooner dissolved in accordance with the laws of the State of-Florida.-

- 3.- Each director and officer of the corporation, weather ornot then in office, shall be indemnified by the Corporation-against all costs and expenses reasonable incurred by or -- imposed upon him in connection with or arising out of any -- claim, demand, action, suit or proceeding in which he may be involved or to which he may be a party by reason of his being or having been a director or officer of the Corporation, said costs and expenses to include attorney's fees and the costs- of reasonable settlement made with a view to curtailment of costs of litigation, except in relation to matters as to --

which he finally shall be adjudged in any such action, suit-or proceeding to have been derelict in the performance of his duty as such officer or director .- Such right of indemnification shall not be exclusive of any other rights to which he may be entitled as a matter of law; and the foregoing right of indemnification shall inure to the benefit of the heirs, executors and administrators of any such director or officer. 4.- A director or officer of the Corporation shall not bedisqualified by his office from dealing or contracting with the Corporation either as a lender, purchaser, or otherwise,nor shall any transaction or contract of the Corporation be void or voidable by reason of the fact that any director or officer or any firm of which any director or officer is a orany corporation of which any director or officer is a stock-holder or director, is in any way interested in such transaction or contract, provided that such contract or transactionis or shall be authorized, ratified, or approved by either: -(a) a vote of a majority of the outstanding shares of the -stock in the Corporation entitled to vote; or (b) a vote of a majority of the board of directors having no interest in such contract or transaction. - A director interested in the contract or transaction who is present may participate in the meeting and may be counted for quorum purposes. - Additionally no director or officer shall be liable to account to the Corporation for any profits realized by, from, of through any such transaction or contract authorized, ratified or approved as herein provided by reason of the fact that he, or any firm of which he is a member or any corporation of which he is a stockholder, officer, or director, was interested in such transaction or contract. Nothing herein containded shall-create liability in the event above described or prevent the authorized approval of such transactions or contracts in any other manner permitted by law.
