ARTICLE I. NAME AND ADDRESS

The name of this corporation is Doc's Mobile Paint Repair, Inc., and the address of the corporation shall be 216 Cedar Key Court, Oldsmar, Florida 34677.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with Section 607.167 Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.


ARTICLE X. INDEMNIFICATION


