To Whom It May Concern:

This letter is in reference to the administrative dissolution by the Department of State on September 16, 2005 of the above referenced corporation. Please note that the taxpayer did not receive the Profit Annual Report, which was originally due on May 1, 2005 or any subsequent communications from the State notifying them that the payment was due. There had been employee turnover in the position that would have normally received this document and the new employees were unaware of this filing requirement and this went unnoticed. We respectfully request that the Department waive the penalty for reinstatement because the late filing was due to reasonable cause and not willful neglect. We are including a check in the amount of \$300.00 for the original report fee for 2005 and 2006. In addition, we have taken internal measures to assure that this does not happen again in the future and that all future reports with the Department of State are timely filed.

Based on the above information, we kindly request that the Department correct the taxpayer's account to reflect the payment of the Annul Report fee, and update the corporation's records to show it as an active corporation.
