ARTICLE I

Name

The name of this corporation is SMITH EXPORT, INC., a Florida corporation.

ARTICLE II

Business

The general nature of the business and the objects and purposes proposed to be transacted and carried on, are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz:

(a) To acquire, own, hold, operate, establish and maintain an export and import business and to export from and import into the United States and its territories and possessions, and any and all foreign countries as principal or agent, merchandise of every kind and nature and to purchase, sell and deal in merchandise of every kind or nature for exportation from and importation into the United States to and from all countries foreign thereto.

(b) To make and perform contracts of any kind and description, and for the purpose of attaining any of the objectives of the corporation, do and perform any and all things necessary or incident to the performing and carrying out of the powers hereinabove specifically delegated or implied, and transact any and all lawful activities and business permitted under the laws of the United States and Florida.

ARTICLE III

Capital Stock

The total number of shares and capital stock which may be issued by this corporation is Five Thousand (5,000) shares of One (\$1.00) Dollar par value common stock.

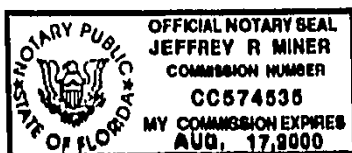
