hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is L Squared Learning Center, Inc.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III

DURATION AND COMMENCEMENT OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate

NATURE OF BUSINESS
