ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is American Russian Environmental Services, Inc. and the principal address and principal place of business is 34931 U.S. Hwy 19, N., Suite 205, Palm Harbor, FL 34684

ARTICLE II - REGISTERED OFFICE AND AGENT
