### Article I - Name

The name of this corporation is Ravi Enterprises, Inc. and its principal office is located at 4520 West Eau Gallie Boulevard, Melbourne, Florida 32934.

### Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.
