ARTICLES OF INCORPORATION OF SPECTRA NETWORKS, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

ARTICLE I - Name

The name of this corporation is:

SPECTRA NETWORKS, INC.

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III - Purpose
