ARTICLES OF DISSOLUTION BY INCORPORATOR

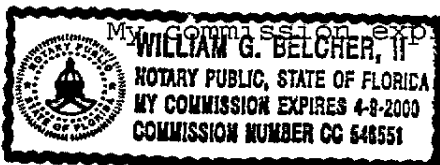
1. The name of the corporation is Spectrum Wireless, Inc.

7. The sole incorporator has elected that the corporation be dissolved.


