ARTICLE I

The name of this corporation is American Leak Detection of Florida, Inc. The principal office and/or mailing address of this corporation is as follows: 1835 Citron St., Charlotte Harbor, FL 33980.

ARTICLE II

This corporation is organized for the following purposes: To carry on any business, occupation, undertaking or enterprise and to exercise any power or authority which may be done by a private corporation organized and existing under and by virtue of Florida Statutes, Chapter 607 (1995), it being the intention that this corporation may conduct and transact any business lawfully authorized and not prohibited by Florida Statutes, Chapter 607, (1995).

ARTICLE III

This corporation is authorized to issue 100 shares of \$1.00 par value common stock, all of which shall be fully paid and non-assessable.

The corporation elects to have preemptive rights.

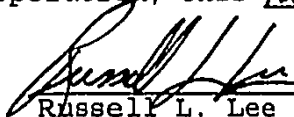

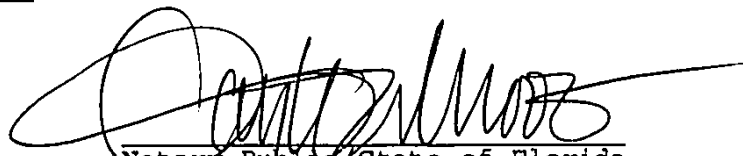

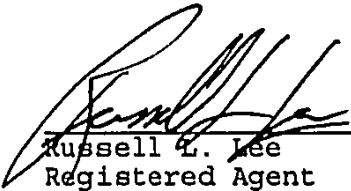
