The undersigned, for the purpose of forming a corporation pursuant to the Florida General Corporations Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I  
NAME

The name of the Corporation is North Florida Realty Group, Inc.

ARTICLE II  
TERM OF EXISTENCE

Existence of the Corporation shall be perpetual. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE III  
NATURE OF BUSINESS

The general purpose for which the Corporation is initially organized is the transaction of any and all business for which corporations may be incorporated under the provisions of Chapter 607 and 475, Florida Statutes.

ARTICLE IV  
CAPITAL STOCK
