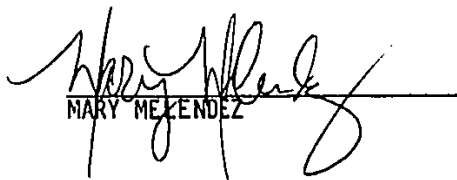

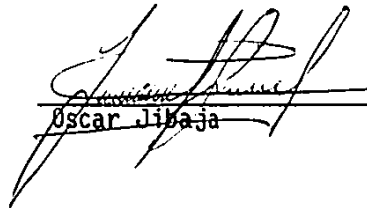
ARTICLE X

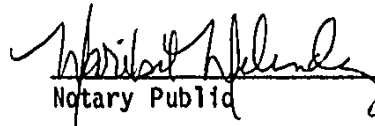

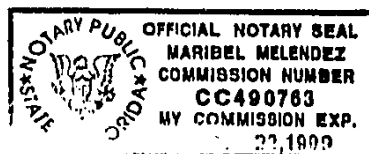

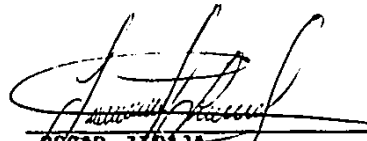
