#### **ARTICLE VIII**

No director of the corporation shall be liable to the corporation or its shareholders for any damages for any breach of duty in such capacity, provided that this provision shall not eliminate or limit: (i) the liability of any director if judgment or other final adjudication adverse to him establishes that his acts or omissions were in bad faith or involved intentional misconduct or a knowing violation of law or that he personally gained in fact a financial profit or other advantage to which he was not legally entitled or that his acts violated the Florida Business Corporation Act; or (ii) the liability of any director for any act or omission prior to the adoption of this Article. If the Florida Business Corporation Act

shall be amended after adoption of this provision to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of the corporation shall be eliminated or limited to the fullest extent provided by the Florida Business Corporation Act, as so amended from time to time. No repeal or modification of this provision by the shareholders shall adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.

#### **ARTICLE IX**

Any action required or permitted to be taken by the Board of Directors may be taken without a meeting if all members of the board consent in writing to the adoption of a resolution authorizing the action.

#### **ARTICLE X**

Any one or more members of the Board of Directors may participate in a meeting by means of a conference telephone or similar communications equipment allowing all participants to hear each other at the same time.
