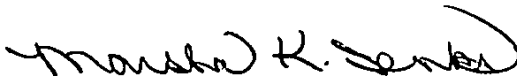

ARTICLE ONE

The name of the corporation is A & R LAWN MAINTENANCE, INC. The principle address and mailing address of the corporation is 1031 Cornwell Drive, Holiday, Florida 34691.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporation may be incorporated under the Florida Corporation Act. The main purpose of the corporation is lawn service.
