

# ARTICLES OF INCORPORATION OF C. T. CRIM ENTERPRISES, INC.



# ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is C. T. CRIM ENTERPRISES, INC., and the principal address and principal place of business is 3020 St. Croix Drive, Clearwater, Florida 34619.

### ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o PATEL, MOORE & O'CONNOR, P.A., 18167 U.S. Highway 19 North, Suite 150, in the City of Clearwater, County of Pinellas, Florida 34624. The name of its registered agent at such address is Patrick M. O'Connor.

## **ARTICLE III - PURPOSE**

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

#### ARTICLE IV - AUTHORIZED SHARES OF STOCK
