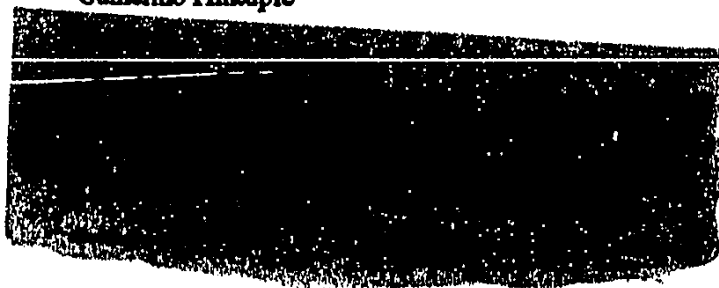

NAME: The name of this Corporation is COMPUTER TECHNOLOGY SERVICES, INC.

ARTICLE II

ARTICLE IX

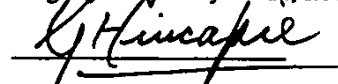
BY-LAWS: The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and in the shareholders.

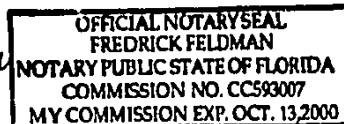
