The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE !

Name and Principal Place of Business

The name of the corporation is Alpha Marine Windows of North America, Inc., and the principal place of business is 437 East Monroe Street, Suite 202, Jacksonville, Florida 32202.

ARTICLE II

Duration

This corporation shall exist perpetually, commencing upon the filing of these Articles with the Secretary of State of the State of Florida.
