ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of the corporation is:

FRONT TO BACK INVESTMENT GROUP, INC.

ARTICLE II

The corporation shall have perpetual existence.

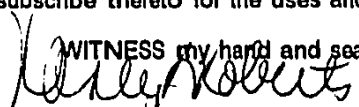

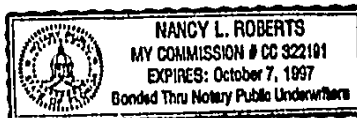
