ARTICLE I

Name

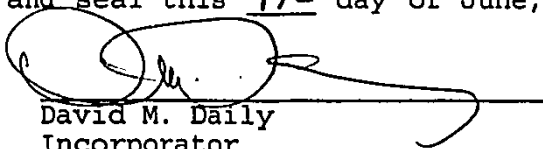
