The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purposes of organizing and incorporating a corporation for profit under the laws of the State of Florida.

Article I

The name of the corporation shall be:

and it shall hereinafter be referred to as the "corporation".

Article II

The date and time on which corporate existence of this corporation shall begin is 12:01 a.m. (Eastern Daylight Time) on the date of filing of these articles and the corporation shall have a continuous and perpetual existence thereafter.

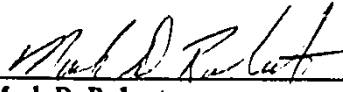
