ARTICLE I. CORPORATE NAME

The name of this corporation is CYM IMPORTS & EXPORTS CORP.

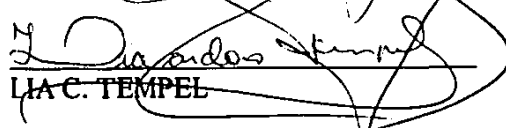

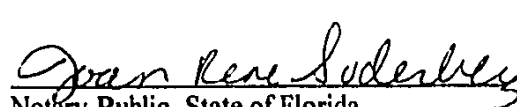

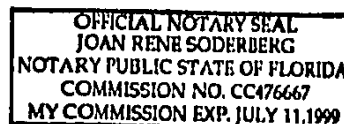
