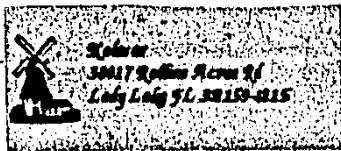

The undersigned, acting as incorporator of a corporation under the Florida General incorporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is FREDERIC P. KOLESAR, INC.

ARTICLE II. DURATION

This corporation shall begin its existence when filed. The period of duration is perpetual.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

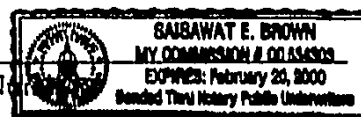
