The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

BROOKS, LORD, TAYLOR AND ASSOCIATES, INC.

The address of the principal office of this corporation shall be 10467 Sunrise Lakes Boulevard, Building 164 Unit 407, Sunrise, Florida 33322, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
