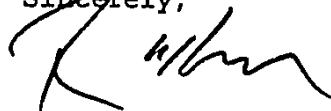

The undersigned does hereby adopt the following
Articles of Incorporation:

Article I

The general nature and business purpose of the corporation is to sell and provide computers and computer consulting services to the general public and also to conduct any lawful business activity permitted by Florida Law.

The name of this corporation shall be BuildIt Computers, Inc.

Article III

The effective date of incorporation shall be upon acceptance of this document and filing by the Secretary of State of the State of Florida, Division of Corporations.

Article IV

Article V

Article VI

The business of the corporation shall be managed by the stockholder and there shall be no directors.

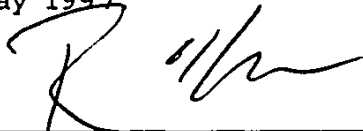
Article X

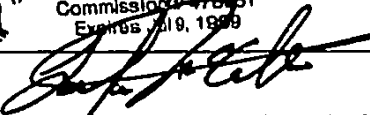

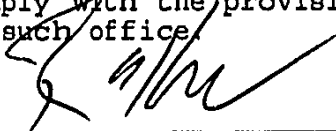
