The undersigned subscriber to these Articles of Incorporation make, subscribe and acknowledge the following Articles of Incorporation under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be: FESTIVAL CORPORATION.

ARTICLE II - TERM OF EXISTENCE

The corporation shall begins its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.
