ARTICLE I

Name and Address

The name of this corporation is SOUTH FLORIDA SURFACES, INC.
and its address is 5406 SW 134 Place, Miami, Fl. 33175.

ARTICLE II

Duration

This corporation shall have perpetual existence.

ARTICLE III

Purpose

This corporation is organized under the laws of the State of Florida, as a corporation for profit, generally engaged in the business of surfacing sun decks, hallways, dryways and patios; repairing roofs, walls, ceilings, etc. or any other business activity permitted by law.
